

**SUWANNEE COUNTY CONSERVATION DISTRICT
MEETING MINUTES
September 18, 2018**

The Suwannee County Conservation District Board of Supervisors held their regularly scheduled meeting Thursday, September 18, 2018 at the USDA-Service Center. Supervisors attending the meeting included: Andy Jackson, Chairman; James Williams, Secretary/Treasurer; Terry Reagan, Supervisor; and De Broughton, Supervisor.

Joel Love, BMP Education Coordinator, discussed the 4R Program proposal to be administered through The District. The Board agreed to do so with Terry Reagan making a motion, followed by a second from De Broughton. Joel also mentioned the upcoming Fall Harvest event to be held at The Research Center.

The next District Meeting will be held October 18, 2018.


OTHER BUSINESS:
