

SUWANNEE COUNTY CONSERVATION DISTRICT MEETING MINUTES

December 19, 2024

The Suwannee County Conservation District Board of Supervisors held their regularly scheduled meeting Thursday December 19, 2024 at 10592 122nd Street in Live Oak, FL 32060. Supervisors attending were Andy Jackson, Chairman; James Williams, Secretary/Treasurer; Terry Reagan, Supervisor; and Larry Sessions, Supervisor. Aalia McClendon, NRCS District Conversationist, gave a report of their current programs and activities. She stated that the Emergency EQIP deadline for applications is December 20, 2024.

OTHER BUSINESS:


